# **ORGANISATIONAL CONTEXT**

At Geronimo, we pride ourselves on being a small support service, providing high-quality Occupational Therapy and Support Coordination for the Melton and Geelong communities.

Geronimo are proud to remain local, to ensure our participants and their families receive a more intimate experience. Having local knowledge and roots in the areas we support enables families to feel connected to their clinician, whilst also providing knowledgeable information on surrounding services and creating strong multidisciplinary networks within the area.

We provide support with an emphasis on increasing skill development and social opportunities – offering individuals more creativity and innovation in service delivery. We are a community based practice who prioritise building positive working relationships with young people and their families, which allows us to successfully develop and implement a range of effective interventions.

Geronimo provide allied health supports across Melbourne's West and Geelong. We operate from local workspaces/clinics in Melton and Herne Hill. We choose to do a select few services well, instead of spreading our resources thin and compromising the quality of our services.

We can provide supports based on the interests and needs of our team – knowing that work should be a nourishing and enjoyable experience. We culturally don't praise one another for overworking, instead prioritizing wellbeing and creating safe, inclusive environments.

#### **KEY DESCRIPTION**

Geronimo provide Occupational Therapy supports to children through to adulthood – focusing on skill development and meaningful participation. This could include conducting functional assessments and developing interventions, support with emotional regulation, increased participation in their communities or supports to better enable them to engage with their peers. Supports may take place in a participant's home, their school, the community, or at our clinic rooms in Melton or Herne Hill.

We have positions available at our Melton and Herne Hill teams, although we encourage staff to work from home wherever this is convenient. Supports will likely involve a large component of community-based supports. The successful applicant will receive an allowance to access professional development opportunities, as well as devices allowing the practitioner to work remotely.



The successful applicant will be able to demonstrate the ability to form positive working relationships with young people and their families, knowledge of the disability services sector, and organisational and record keeping skills.

#### Position Prerequisites:

- Bachelor of Occupational Therapy or equivalent
- Current AHPRA registration
- Preferred prior experience supporting people who have a disability
- A valid Working With Children Check (WWCC) & NDIS Worker Screening Check
- A valid driver's license

The successful applicant will be subject to a 6-month probation period.
